### The ACES Program Mission Statement:

*“To assist the first generation, low-income student in the graduation and transfer process from College of the Desert and to strengthen their preparation for the successful completion of the Bachelor’s degree goal.”*

## What is TRIO ACES-SSS?

The ACES-SSS (Student Support Services) Program is federally funded under the U.S. Department of Education's TRIO Programs. ACES is designed to support participants in meeting the challenges of graduating from College of the Desert and transferring to a four-year university. ACES emphasizes academic, career, personal counseling and educational services to help students meet their goals.

### How to Apply to ACES-SSS

- Complete and submit an ACES application
- ACES will call you to schedule an interview with an ACES Counselor
- Bring Income Verification to the interview (i.e., Income Tax)

## Who is Eligible for ACES-SSS?

ELIGIBILITY FOR THE ACES PROGRAM IS BASED ON THE FOLLOWING CRITERIA:

- Financial Need (Meet federally established low- income guidelines)
- First Generation College Student
- Academic Need
- Academic Potential (minimum 2.5 GPA)
- Plan to Graduate & Transfer to a four year college or university
- Freshman Status (have completed 24—30 transferrable course units)
- Full-Time Status (be enrolled in at least 12 units per semester)
- Residency Status (be a U.S. citizen or a permanent resident of the U.S.)
